Medina County Clerk of Courts Dave Wadsworth's Office is the guardian of the records of the Courts as well as the agent for auto title transfers. Elected to a four-year term, the Clerk's office employs approximately 40 people in his Legal and Title divisions. Civil, Criminal, Domestic Relations and Archives departments make up the legal division. The Clerk serves the two Common Pleas judges, the Domestic Relations judge the 9th district court of appeals and the public. Pleadings, exhibits and other documents are managed, published, microfilmed and maintained by the Clerk. In the Auto Title division, the Clerk maintains offices in Brunswick, Medina and Wadsworth. Titles of autos, motorcycles, watercraft and other vehicles are verified and transferred by the deputy clerks working in the title division. The division works closely with the Ohio Bureau of Motor Vehicles to maintain the records of the many vehicles titled in Medina County.

Medina County Office for Older Adults serves all seniors in the county with assistance in the areas of meal provision, benefit work and transportation. Our home delivered meal program serves well over 40,000 meals to seniors in need throughout the county and is the only meal program offered free of charge to seniors in need. The Medina County Commissioners make this service possible by Title III funding provided by the Western Reserve Area Agency on Aging through the Ohio Department on Aging. This limited grant funding is boosted by every donation received. Those benefitting from the program are homebound individuals who aren't able to prepare meals on their own. They are able to "age in place" because of the services provided. Additionally, we see our seniors four days per week with hot meals and a smile and we always check to make sure they are safe within their homes. This in an invaluable service to seniors in Medina County and gives peace of mind to caregivers who are not able to see their loved ones on a daily basis. To learn more, go to www.mcooa.org
